


Canadian Dental Care Plan (CDCP)



The Liberal government is committed to the health of Canadians and supporting families and seniors.

Who can benefit from the Canadian Dental Care Plan?

- ✓ Eligible seniors aged 65 or older
- ✓ Eligible adults aged 18 to 64
- ✓ Children aged 18 or younger
- ✓ Since May 2025, eligible persons aged 18 to 64

Eligibility requirements (aged 18 to 64 years)

To qualify, you must:

- ✓ not have access to private or group dental insurance
- ✓ have an adjusted family net income of less than \$90,000
- ✓ have filed your 2024 tax returns
- ✓ be a Canadian resident for tax purposes

Canadian Dental Care Plan
expanded to ages 18 to 64

Attention: Members already enrolled in the CDCP must renew before June 1, 2025, for the 2025–2026 period.

Did you know?

Since its creation in December 2023, **more than 3.4 million** Canadians have joined the CDCP. Over **1.7 million** have already received dental care. In the long term, **more than 9 million** Canadians will benefit from dental care through this plan.
